The Portuguese Network on Coastal Research, PoCoast, will organize in May 2008, at the Faculty of Engineering of the University of Porto, the 1st PoCoast Seminar on Coastal Research, dedicated to the ENCORA scientific themes, and an extra one.

The PoCoast network aims at creating a self-sustaining platform for coastal research, to reinforce cooperation and coherence between existing networks, to create new alliances and to foster better mechanisms for communication. The network promotes knowledge-sharing, for problem solving and new solutions relevant on coastal zone management.

Strengthening the knowledge base on coastal management and planning is also an objective of the network, through the development of promising strategies of information management and the development of new synergies within and between the communities of coastal sciences and coastal practice.

In the European context, the PoCoast network is the national network of ENCORA, the European Network on Coastal Research, a Coordination Action funded under the 6th Framework Programme of the European Union.
